2. **THIS COURT ORDERS** that legal fees of 30% of the Settlement Amount in the amount of EUR 2,265,000 plus applicable taxes and disbursements of CAD \$208,765.49, plus applicable taxes, are granted to Class Counsel as being fair and reasonable.
3. **THIS COURT ORDERS** that Class Counsel's approved legal fees plus applicable taxes and Class Counsel's approved disbursements plus applicable taxes shall be paid from the Settlement Amount.
4. **THIS COURT ORDERS** that an honorarium in the amount of CAD \$6,000 be paid to the Court-appointed Representative Plaintiff, Brad Lundell, as a disbursement from the Settlement Amount.
